

EQUIPMENT, RENT & TERMS OF RENTAL AGREEMENT:

- The undersigned as Lessee, hires from King o' the Castle as Lessor, one bouncy castle, identification name as:

DELIVERY:

- To the street address specified by Lessee (Customer).
- Lessee grants lessor right to enter the property at the said address ("Delivery Address") for the delivery and subsequent pick up of the King of the Castle bouncy castle at the specified time.

TRANSPORTATION EXPENSE:

- Except as provided herein, all charges in delivering and subsequent pick up of the King of the Castle bouncy castle with respect to the Delivery Address are included in the Rental Fee noted above.
- In the event that Lessee does not return the bouncy castle at the appointed time to Lessor then \$50 Transportation Fee shall be automatically imposed.

CHILDREN'S SAFETY DEPENDS ON YOU AT ALL TIMES. YOUR PERSONAL SUPERVISION IS ABSOLUTELY REQUIRED. AS THE LESSEE OF a KING O' THE CASTLE UNIT, THE SAFETY OF ALL USERS IS YOUR RESPONSIBILITY.

GENERAL RULES TO FOLLOW DURING THE USE OF THE BOUNCY CASTLE:

- All users MUST REMOVE SHOES before playing on the bouncy castle.
- To avoid neck and back injuries, FLIPS ARE NOT ALLOWED.
- Absolutely no "SILLY STRING", GUM, CANDY, FOOD or other sticky substances are allowed on the bouncy castle. If, upon pick up, such cleaning is required then a cleaning fee shall be automatically imposed.
- Absolutely NO PETS are allowed on the bouncy castle.
- DO NOT MOVE the bouncy castle from the place where it was installed. If the bouncy castle moves, pull the corner back to its original location of installation.
- **CAUTION: KEEP THE UNIT AWAY FROM SWIMMING POOLS.**

SPECIAL INSTRUCTIONS: The bouncy castle equipment is reliable. Should the bouncy castle deflate:

- Before attempting to fix any problems ensure that all users are removed from the unit.
- The motor may have stopped, in which case, check the cord connection at the outlet near the motor, and remember to keep only the supplied extension cord or blockage, and check both tubes at the back of the bouncy castle for snugness: re-tie if necessary.

At no time shall the Lessee attempt to mechanically fix or change any components of the bouncy castle or accessories.

SAFE OPERATION ACKNOWLEDEMENT :

- Lessee acknowledges that he/she has been instructed about and fully understands the safe operation of the bouncy castle that is subject of this Rental Agreement.
- Lessee agrees to observe all safety precautions.
- Lessee also represents and warrants the safe return of the unit and hereby agrees to pay the full price on hired items, if it not returned.

MAINTENANCE: Lessee agrees to keep the bouncy castle in the same condition as when received, ordinary wear expected.

ALTERATIONS AND ATTACHMENTS : No alteration in or attachments to the bouncy castle will be made without prior approval of Lessor.

WARRANTY:

- Lessor warrants that the bouncy castle leased under this Rental Agreement will be in good working order on the effective date of the Rental Agreement.
- The bouncy castle is supplied and maintained subject to this warranty.
- Lessor's obligation under this Rental Agreement is limited to repair or replacement of the bouncy castle when Lessor determines the unit does not conform to this warranty.
- This warranty is in lieu of any and all other warranties expressed or implied, and of any and all obligations and of all liabilities on the part of the Lessor for damages, including, but not limited to, consequential damages, arising out of or in connection with the use or performance of the bouncy castle.

TITLE:

- Lessee agrees to keep the bouncy castle in his/her custody not to sublease, rent, sell, remove from Delivery Address, or otherwise transfer such bouncy castle.

- The bouncy castle will remain the property of the Lessor and may be removed by the Lessor at any time after the termination of this Rental Agreement.

RELEASE OF LIABILITY:

- The lessee shall be in charge of the bouncy castle’s operation, and is fully responsible for its operation as well as return of the bouncy castle in good working order.
- Lessor and it's officers, employees and agents is/are not responsible for injury occurring to the Lessee or any other persons using the bouncy castle, and the Lessee further agrees to hold the Lessor and its officers, employees and agents free and harmless against any injury or claims.
- The Lessee shall indemnify the Lessor and its officers, employees, and agents from/against any costs incurred due to claims from anyone and for lawyer fees and related costs involving the use and return of the bouncy castle, should legal action become necessary.

ENTIRE AGREEMENT:

- The Rental Agreement constitutes the full agreement between Lessor and Lessee.
- Time is of the essence in this Rental Agreement.
- The receipt of the bouncy castle that is subject of this Rental Agreement is in good working order and repair and this is so acknowledges by the Lessee.

RAIN POLICY:

- During periods of severe weather conditions (i.e. heavy rain, high winds, electrical storms etc.), we reserve the right to cancel your reservations to ensure the safety of all involved.
- If conditions are not too severe you have the option of keeping it or not.
- If you decide to keep the unit for the term of this Rental Agreement, once the bouncy castle has been delivered & installed there will be no refunds!
